## 1. DISTRIBUTION AND SCOPE

### 1.1. DISTRIBUTION

1.1.1. The intended audience is all members who are or intend to become a HKvACC-partnered streamer.

### 1.2. SCOPE

1.2.1. This document is written to outline the roles, permissions and restrictions of a HKvACC-partnered streamer.

### 1.3. EXCLUSION OF LIABILITY

1.3.1. This manual is for use on the VATSIM Network only and should never be adopted for real world use. The information published by VATSIM within this document is made available without warranty of any kind; the organization accepts no responsibility or liability whether direct or indirect, as to the currency, accuracy or quality of the information, nor for any consequence of its use.

## 2. BACKGROUND

2.1. After switching to the new discord server on 15<sup>th</sup> April 2021, the streamer role no longer exists in the server. However, there are still a number of streamers active within HKvACC. In order to create a positive relationship between these streamers and HKvACC, we are introducing the streamer role once again.

## 3. PREREQUISITES FOR ATTAINING THE STREAMER ROLE

3.1. Applicants must have at least 20 followers/subscribers on the channel.

3.2. All content available on the applicant's channel must abide by the VATSIM CoC and CoR.

3.3. At least 5 videos, with at least 5 minutes in length each, related to VATSIM are required.

3.4. Majority of the channel content should be aviation related.

## 4. REQUIREMENTS FOR RETAINING THE STREAMER ROLE

- 4.1. Streamers must upload at least one VATSIM-related video/stream on the partnered channel per month.
- 4.2. Streamers must upload at least one video/stream of flying/controlling in Hong Kong FIR every three months.
- 4.3. Streamer's content will be reviewed by HKvACC staff regularly. Streamers have the responsibility to ensure that all content (including comments) on the partnered channel abide by the VATSIM CoC. Any inappropriate content should be removed in a timely manner.
- 4.4. If a partnered streamer does not meet the requirement stated above, his/her streamer role may be removed without notice.
- 4.5. If any streamer would like to have the role removed, he/she may contact any HKvACC staff directly with the request.

## 5. PRIVILEGES OF THE STREAMER ROLE

- 5.1. The streamer role will be displayed separately in the discord server.
- 5.2. Members who holds this role have access to sending messages in #streamers-announcement. Note that the VATSIM CoC applies to the channel as well.
- 5.3. Streamers may advertise each of their streams/videos once on the channel.

## 6. APPLICATION FOR THE STREAMER ROLE

- 6.1. To apply for the streamer role, applicant should first ensure that his/her channel has fulfilled the prerequisites listed in Section 3 of this document.
- 6.2. Applicants should open a ticket at HKvACC Helpdesk (<http://helpdesk.vathk.com/>), with a link to his/her channel.
- 6.3. The application will be reviewed by HKvACC within 24 - 48 hours. Applicants will receive an update on the ticket once the application is processed, no matter the application is accepted or denied.
